

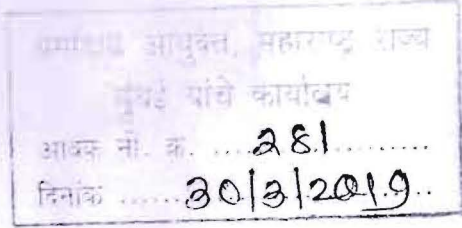

Sub: BRAP reforms for the year 2018-2019.

Sir,

With reference to the subject noted above, I am directed to inform you that the Department of Industrial Policy and Promotion (DIPP), Government of India has taken objection on physical touch point during Registration of Society and the EY, i.e. the coordinator for BRAP has informed to issue necessary orders for removing physical touch point during Registration of Society for total compliance of Reform No.79. The DIPP has recommended to eliminate physical touch point for document submission.

In the discussion with the officials of the Charity Organization, it revealed that the Members of the Society are required to physically file the documents in view of the provisions of Section 2 of the Societies Registration Act, 1860. However, it is not expressly provided in the said Section that the Memorandum of Association shall be filed, in person. Therefore, there appears no legal impediment in issuing practice note/Circular to discontinue the present practice of personally filing the documents before the Authority under the said Act.

I am, therefore, directed to request you to issue practice note/Circular to all the concerned to eliminate physical touch point for document submission.
