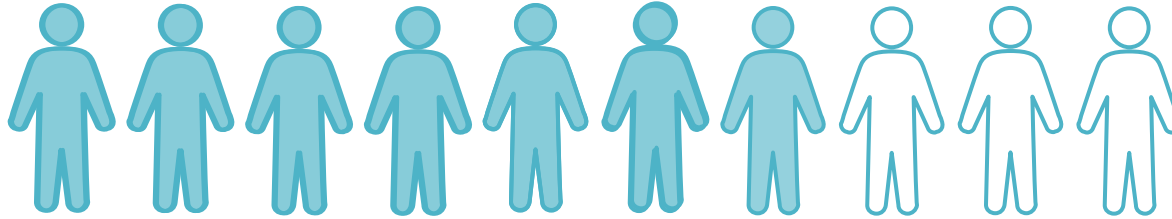
## Ahmednagar Office (2016-17)
