**CALLING OF EXPRESSION OF INTERST FOR PREPARATION OF PANNEL
OF ADMINISTRATOR/FIT PERSON/CARETAKER OF TRUSTS.**

For this purpose expression of interest is requested from - retired Judge of Hon'ble High Court of Bombay, retired Charity Commissioner/Joint Charity Commissioner/Deputy Charity Commissioner/Assistant Charity Commissioner, retired Principal District Judge/District Judge, retired Superintendent/Inspector of the Charity Organization. Those who are

They shall specify the particular region/s for which they are giving willingness. Retired Superintendent and Inspector may be called for personal interaction to assess suitability. Empanelment shall be solely within the discretion of the Charity Commissioner.
